The rate of deposit increased by 1000% within 12 months following the switch-on of the publication prompt in Elements.



#### Open Access that works for you

Measuring engagement with Open Access policies can be time-consuming and difficult. Administrators often spend valuable time chasing researchers, navigating across systems, and managing varied requirements. The OA Monitor is designed to engage researchers and align with the unique needs of your institution. Homepage prompts guide users to deposit outputs in just a few clicks, with messaging tailored by department or role. Guidance from Jisc's Open Policy Finder is embedded by default, with the option to layer in your own institutional advice.

The OA Monitor offers flexible support and tracking for a range of Open Access pathways (including Gold, DOAJ-indexed outputs, and Green or repository-based routes). Policies can be targeted by funder, publication type, or user group.

### Simplify compliance monitoring across multiple policies

With real-time visibility and granular control, the OA Monitor simplifies the challenge of tracking and reporting against multiple concurrent policies. Institutions can easily monitor who has deposited and where, confirm that correct versions are in the right repositories, and track whether outputs meet funder-specific reuse licence requirements.

Non-compliant or incomplete outputs are automatically flagged for follow-up, while exceptions and opt-outs can be recorded in bulk. Administrators can generate reports by policy, researcher, or department, and even empower dedicated OA Managers with role-based access to manage workflows and take action where needed.
